**Subject: Har Ghar Tiranga Programme under Azadi ka Amrit Mahatsov– Reg.**

Respected Madam/Sir,

As you are aware, Azadi ka Amrit Mahotsav (AKAM) is an ongoing celebration to commemorate the 75 glorious years of a progressive independent India. This initiative by the Government of India aims to bring focus on our freedom struggle and on the milestones we have achieved as a nation.

Under the aegis of AKAM, a campaign 'Har Ghar Tiranga' has been launched to encourage the citizens to hoist the National Flag of India in their homes. It is envisaged that all citizens will be encouraged to hoist Tiranga in their home during the period **13-15<sup>th</sup> August**.

For awareness building and buzz creation, HEIs may also organize Nukkad Nataks, Prabhat Pheries, presentations etc. with a specific call to action on Buying/Gifting a Flag. Flags can be purchased, gifted from [www.harghartiranga.com](http://www.harghartiranga.com). It is mandatory to obey the 'Flag code of India' 2002 (**enclosed**), to govern the usage of the National flag by the citizens.

In this regard, all the Vice-Chancellors of Universities and Principals of the colleges are requested to **disseminate the information on Har Ghar Tiranga** program with their faculty members, students and stakeholders and to encourage them to urge their family members to hoist the National Flag in their respective households during the period from **13<sup>th</sup>-15<sup>th</sup> August, 2022** and making the 'Har Ghar Tiranga' Campaign a resounding success.

Institutions are also requested to upload their participatory videos of 'Har Ghar Tiranga' programme on their social media platforms like Twitter, YouTube, Facebook, Instagram etc. and also share the detailed activity plan for organizing the above events on the UGC University Activity Monitoring Portal (UAMP) <https://uamp.ugc.ac.in> **latest by 25<sup>th</sup> July, 2022**.
